

Bids shall be faxed July 10, 2001, 2:00 p.m. to The Home Depot, Construction Department, 15 Dan Rd., Canton, MA 02021, Attention: Pat Burns. Late bids will not be accepted. All bids shall conform to invitations to bid section of the specification. Deviations from the section shall

invalidate the bid.

Although the Pre-Bid Conference has taken place via telephone, it is still each bidders responsibility to visit and become familiar with the site.

The Pile and Structural Slab design is being revised. Bidders are instructed not to bid these items at this time. An addendum incorporating this change will be issued 6/22/01 with delivery to bidders on 6/25.

Schedule:

Refer to page 4 of 5 of the "Bid Proposal Form".

At the (5) week walk The Home Depot will need the Temporary Certificate of Occupancy and the project must be DONE.

Six (6) weeks prior to turnover The Home Depot will commence with fixturing the store.

4. **CONTRACT COMMENTS**

Contract allows THE HOME DEPOT to take over entire project due to failure to perform.

Updated construction schedule and construction progress photos are to be submitted during the course of construction.

Each bidder is responsible for reading and understanding the General Conditions, in particular Sections 1.1.3, 1.2.2 and 1.2.3.

The General Contractor is buying this project in its entirety. The Home Depot will not accept change orders for anything other than changes in scope of work initiated by The Home Depot. The Home Depot needs (3) signatures internally prior to authorization of any change order.

The General Contractor is responsible for the warranty for all items that are furnished by The Home Depot (in addition to items that are furnished by the General Contractor).

The General Contractor is responsible for assuring all materials including those furnished by The Home Depot, are delivered to the job site in a timely fashion.

Included in the Pre-bid addendum will be the new General Conditions dated April 1, 2001 and a Work Directive form.

5. BID FORM & BIDDING PRACTICES

The Home Depot encourages open bidding practices. The Home Depot is not mandating, in any way, that certain subcontractor's be used for any portion of work. The Home Depot does, however, reserve the right to have the general contractor replace a subcontractor, at its direction.

All items on the bid proposal form are to be completed in their entirety, as applicable. Where items are not applicable, the General Contractor should indicate "N/A". Any bid proposal forms that are not completed will be rejected.

Overhead and Profit shall be limited to 6% maximum on the Bid Proposal Form. The awarded bidder will need to change this by hand on Page 3 of the Agreement Between Owner and Contractor. The awarded bidder will also need to indicate "30" in the blank space provided under Article 6 on Page 4 of the Agreement Between Owner and Contractor.

Allowance for winter conditions and rain to be included in the bid.

All unit prices are to include the 6% maximum overhead and profit.

Any questions or clarifications must be submitted one (1) week prior to bid due date, otherwise the General Contractor bought item.

6. BONDING REQUIREMENTS

Bid Bond not required.

Performance Bond will be required in the amount of bid. This item shall be listed as an alternate price in the bid breakdown form.

Bonding company information must be provided in proposal, including the company name, address, phone number and contact person. The bidder must be bondable and must include a cost for bonding.

7. PERMIT

Building permit is paid for by Owner – Successful bidder will be asked to expedite the permit if it is not available at the time of contract award.

The initial building permit fee will be the responsibility of The Home Depot. All subsequent permitting and /or utility connection fees, one time charges and inspection fees, are the responsibility of the General Contractor.

8. TEMPORARY UTILITIES AND CONNECTION FEES

All connection fees, both temporary and permanent, are to be included in the contractors bid.

The cost of all utilities consumed will be the responsibility of the contractor until the Owner accepts the facility.

All utility costs are to be included within the base bid cost and contract amount.

9. SUBCONTRACTOR LIST

The names of all subcontractors is to be submitted to THE HOME DEPOT prior to the award of the subcontract.

10. OWNER – FURNISHED ITEMS TO BE INSTALLED BY CONTRACTOR.

Refer to drawing and specs for all owner supplied, Contractor installed items. Contractor responsible to receive, unload, store, insure, protect, inventory and coordinate installation, etc., of all Owner supplied items until incorporated into work. Any shortage or damage to be reported to THE HOME DEPOT upon receipt. Contractor shall coordinate the ordering and delivery of all items so that they are done in a timely fashion. The owner shall not be responsible for delays caused by late delivery due to the contractors negligence in ordering, pick up, etc.

11. SPECIFICATIONS: Refer to specification Division 1

Dallas, Texas

No brand name specified – product proposed must meet specified performance standards. (Example: AISC Standard, ASTM Standard, ANSI Standard, etc...)

Two or more brand names specified – product proposed must meet specified performance standards. Bidder must verify the compatibility of other specified brands.

Some of these items are to be purchased through national account arrangements - refer to specification for details.

12. SUBMITTALS Refer to specification

Submittals must be reviewed and accepted by G.C. (as evidence by G.C. Stamp on shop drawings) prior to submission to CASCO. This <u>includes</u> items purchased through National Accounts.

Shop drawing turn-around is typically 5 working days. If overnight return delivery is required, G.C. is to give CASCO his overnight agents account number for expediting drawings.

Required for: Asphalt mix designs, concrete mix designs, reinforcing steel, masonry block samples and strength certification, (and construction of sample panel at site with all colors of block and mortar) structural steel, metal deck, bar joists, fire sprinkler system (including underground piping from public water main to building).

Structural steel and joist shop drawings must be signed and sealed by an engineer registered in the state in which construction occurs for connection design.

Quality Assurance Testing will be provided by THE HOME DEPOT and will monitor work and materials.

13. MISCELLANEOUS ITEMS

The "covered A-frame structure" in the Garden Center will not be furnished by The Home Depot. This should be furnished (from Rough Brothers, Inc., 5513 Vine Street, Cincinnati, Ohio 45216, 1-800-542-7351) and installed by the successful bidder.

The bidders are to include 30 additional 4" heavy duty fence bollards (including installation) in their bids to be installed at the Kitchen Area.

The "kitchen walls" are not to be included in the bids.

Roofing – The bidders can select to use EPDM, TPO or PVC Roof. The details on the drawings relate to an EPDM Roof.

The structural steel joists, joist girders and metal decking (material only) (including decking at the front canopies) will be furnished by The Home Depot. Documents have been sent to the steel vendor.

Deck lap screws are to be provided by the contractor.

Paving is to be completed 30 days prior to grand opening.

The General Contractor is responsible for ordering and bringing six (6) phone lines to the two (2) hiring trailers.

All steel fabrication to include new OSHA Requirements.

This is an unclassified site.

The railroad is not to be used as an access area.

The Pre-cast soundwall details will be issued as an addendum.

Offsite General Contractor shall be responsible for vertical granite curb along RT1.

The Electrical Contractor owns Drawing E1.

The trees and shrubs in the Wetlands Mitigation Area must be installed exactly as per the plan.

The General Contractor is responsible for verifying which trees are to remain. (Drawing L1, Note #12).

14. PILES

Piles are to be measured from tip to cut-off length. The Home Depot will specify length of piles as a lump sum length to be bid. (All-inclusive).

The Pylon sign will require three (3) piles for support.

GSI to confirm recommendations for obstructions during pile driving.

The General Contractor is responsible for pile load tests as per the Geotechnical Report, including associated costs. Geotechnical Services will inspect the required load tests.

No piles are required under the transformer pad, parking lot light fixture bases or monument sign.

All piles shall have a cap plate to prevent the pile from punching through the slab.
